It is due to be relaunched as a closed group as your committee is concerned that it might start attracting poachers.

It depends on the number of vacancies and recruitment for next season when the list will be reopened.

## A Busy Season

River works got underway in February when a number of eager and enthusiastic volunteers started cutting-back the overgrown willows on the Jamiesons' bank immediately downstream from Yarrow Bridge. Much of this work was hampered by very high water, similar to the levels experienced at the end of the season. It was successful in the end and this stretch of the river can now be fished much more easily.

The fence and rusted gate at the rear of the parking area by Yarrow Bridge has been replaced and the new gate gives easy access to the right-hand bank above the bridge. The trees have also been cut back to allow this stretch of the river to be fished by members only.

The banks were cut twice by the tractor cutter and strimmed regularly. Small scale tree pruning was carried out as necessary.

A large quantity of stone was put into the cattle drink on the Bintry Mill Beat to reduce damage to the river bank and to help prevent silt getting into the river.



A lot of time and effort went into in-channel work to reduce the amount of unwanted weed growth. The weeds included those with large cabbage-like leaves, others that resemble chives which have gone to seed and plenty of ribbon weed. This work is ongoing.

This year saw the first full weed cut for a number of seasons and involved a large group of members. The two days of cutting using the punt were preceded by selective hand-cutting of shallow areas and more hand cutting was done afterwards. A considerable amount of weed was cut and removed from the river, mostly by using a 360 excavator. While the electric cutter is quite efficient, raising and lowering it as the river depth changes is very hard work. We are looking at mechanising this in some way for next season.

## **County School clearance**

The work on the willows on the Yarrow Farm Beat was very similar, but on a much smaller scale than the major tree surgery planned for the County School Beat. The start of that work has been delayed in part due to the heavy autumn rains but also the gales at the end of September meant most tree surgeons are fully booked for quite some time. The volume of material to be cut down and processed is more than can be managed by club members however enthusiastic they may be. When the trees are cut back most of the beat will be fishable again.

A major restoration is planned for next spring on the County School beat to improve access and habitat.

Gravel jetting had been planned to start in late September but was "washed out" by the heavy rains which left the river far too high and coloured to be able to do it successfully. We may need to make a start at the beginning of September next season in case we have similar weather in order to get the work done before the early spawners start their activities.

## Bintry Mill Trout Fishery Financial Report 2020

#### **Income and Membership**

Overall income for 2020 of £15,575.00 was a slight decrease on the 2019 figure. As fewer ceased their membership there was a reduction in joining fees. This reduction in income was offset to some extent by the increase in day-ticket income.

Day Ticket Sales increased from 67 to 87

#### Expenditure

Stocking cost was decreased by  $\pounds 641.10$  on last year's figure due to Covid 19 restrictions.

Admin expenses decreased by £165.28.

River Maintenance decreased by  $\pounds$ 796.63 due to more effective river management and hard work by our River Manager.

River Improvement decreased by £5,062.20. No river improvement works were carried out.

Other expenses were in line with the previous year.

Accruals relate to unpaid river maintenance expenses as at 31st October 2020

## **Financial Summary**

**2020 - a Surplus of £6642.16** – Surplus due to reduction in stocking and no river improvement works.

**2019 - a Surplus of £1513.69** – Income increased resulting in surplus. This also takes into account the extraordinary River Improvement of £4512.

2018 - a shortfall of -£732 - Note: see Treasurers report 2018.

**2017 - a shortfall of -£1117** – Note: this is operational shortfall and ignores the cost of the 40th Event.

2016 - a shortfall of -£1055

The fishery was again self financing in 2020, the second year running. We hope to achieve this year on year going forward to secure the future of the club and enable surplus funds to be used for river improvement.
